

## **"Promo hOn and AWorld 2025" prize draw**

### **How to enter the prize draw:**

During the promotional period, from 01/10/2025 to 31/12/2025, to take part in this initiative the Entrant must access the hOn App owned by the Promotion Company, log in with their credentials, or if not yet registered complete registration by entering the personal details required.

Within the hOn App the Entrant will find a dedicated section where the methods of participation can be consulted together with the invitation to access the Aworld community section dedicated to hOn (Haier).

The hOn App can be downloaded free of charge on iOS, Android and Huawei operating systems.

The Entrant who, after registering, accesses the Aworld community section dedicated to hOn (Haier) may begin earning points according to the methods described in the following paragraphs in order to reach the point threshold required to take part in the final draw for the prizes on offer.

At the end of the promotional period, among all Entrants who have earned a score equal to or greater than 200 XP, a random draw will be held for the award of the ten (10) final prizes.

A prerequisite for participation in the draw is reading the privacy policy and accepting the rules.

### **Earning points:**

Entrants may earn points (hereinafter "XP") by taking part in the various activities available within the hOn App in the AWorld community section dedicated to hOn (Haier) as follows:

- Stories: +20 XP for each story read.
- Quizzes: completing each quiz correctly awards +5 XP for an easy quiz, +10 XP for a medium quiz, +15 XP for a difficult quiz.
- Daily routines: three types are available "morning", "afternoon", "evening". For each type of routine it is possible to record an unlimited number of actions, but only +5 XP will be awarded for each type of routine performed (morning, afternoon, evening) up to a maximum of +15 XP per day.
- Mobility: the system has four mobility levels based on movement targets. The XPs awarded on reaching each level are as follows:
  - Level 1: +10 XP
  - Level 2: +25 XP
  - Level 3: +50 XP
  - Level 4: +100 XP
- Wellness: completing wellness activities (steps and physical activity) awards +105 XP. It is necessary to have linked the phone function that monitors physical activity to one's profile.
- Invite a friend: for each friend who correctly registers on the AWorld app using the invitation code, the Entrant who sent the invitation will receive +200 XP.
- Customised hOn content: +10 XP for the content read. Only one hOn content item will be available in the Community section. Once read, the content will no longer be accessible to the Entrant.

Moreover, each Entrant will have 15 "seeds" per day that can be used to enable certain activities: 2 "seeds" for each Story and 1 "seed" for each Quiz. These "seeds" allow the Entrant to access extra content and functions of the App not connected with this prize draw.

The number of "seeds" is automatically replenished every 2 hours. Any "seeds" used by the Entrant to enable Stories and Quizzes will become available again during the day, it being understood that the maximum accumulation is 15 "seeds".

### **Final draw:**

At the end of the promotional period the Promotion Company will prepare a database containing the names of all those entitled to take part in the final draw, namely all Entrants who have reached a score equal to or greater than 200 XP.

10 winners and 10 runners-up will be selected from the database.

The random drawing will take place by 28/02/2026 in the presence of a notary or a representative of the Chamber of Commerce.

The runners-up will only be used in the event of unallocated or unclaimed prizes and will be contacted following the order of the draw.

Before confirming and awarding the prize, the Company reserves the right to verify compliance by the winner with the prize draw participation conditions.

#### **Restrictions:**

Participation in the draw is permitted exclusively for adult persons resident or domiciled in one of the following countries: Italy, Germany and the United Kingdom registered on the hOn App.

Each Entrant may take part in the final draw with a maximum of one (1) entry.

#### **Market value of the prizes:**

The total prize amount is €1,098.35 (excluding VAT). The market value of the prizes refers to the date of publication of the rules.

#### **Winning notification:**

The Promotion Company will notify winners within 5 working days of the date of the draw report, with instructions for claiming the prize.

The Promotion Company reserves the right to request that winners sign an acceptance form and send a copy of a valid identity document. Winners will be given no less than 5 days to respond.

If a winner fails to respond within the specified time and/or does not have what was requested, or in the event of untraceability of the winner, being under 18 years of age, multiple prizes or in the event of any other irregularity, the prize will be deemed unawarded. **Waiver of the right to recover deductions at source:**

The Promotion Company waives the right to recover withholding tax at source in favour of winners (Article 30 of Italian Presidential Decree no. 600 of 29/09/1973).

**Transfer of the prize:**

The winner may not transfer their prize to third parties.

**Refusal of the Prize:**

If the winner should expressly refuse the prize, it can remain at the disposal of the Promotion Company.

**Server location:**

The Promotion Company declares that the server for collecting participants' data is located abroad. A mirror system solution was adopted to replicate data on a server located in Italy. The Promotion Company agrees to provide the Public Administration with the database relating to the prize draw upon simple request made also to the company's tax representative or to the person who is legally entitled to have judicial and extrajudicial relations with the PA.
